

CONSENTS FORM



Sometimes we take photographs or videos of children either at the school or when they are involved in organised activities away from the school site. We may use the pictures, or video recordings, in school publications, such as the prospectus, and on our website. We may also make video or webcam recordings for use by the school. To comply with the General Data Protection Regulation (GDPR) 2018, we need your permission to photograph or make any recordings of your child.

Occasionally, the school may be visited by the news media (usually local newspapers) to take photographs or film of an event at the school. Students will often appear in these images, which will be published in local newspapers or even broadcast on television. Please note that their first and last name may appear with the photograph or video.
